Background Information on Field Trip Sites

Phon D Sutton Recreational Area: Guided by Jacob Draper (DFFM) and Justin Eddinger (Ecoculture)

Project Objective: Riparian restoration. Treatment of salt cedar, buffelgrass, and fountain grass.

The Lower Salt River Restoration Project (LSRRP) is located in the Mesa Ranger District, Tonto National Forest (TNF). The LSRRP is a collaborative partnership between the Ecoculture, National Forest Foundation (NFF), Northern Arizona University (NAU), Arizona Department of Forestry and Fire Management (DFFM), and the TNF. This long-term collaborative restoration initiative started in 2018 after the 818-acre Cactus Fire. The goal is to reduce/eliminate non-native invasive species and restore native riparian plant communities along the approximate 14-mile stretch of the Lower Salt River (LSR) from Stewart Mountain Dam downstream to Granite Reef Dam.

Treatment began in 2018, focusing on salt cedar (*Tamarix* spp.) and giant reed (*Arundo donax*) removal. The LSRRP is poised to make tangible progress towards rebuilding the ecosystem, restoring natural diversity, benefitting wildlife, and increasing high quality water to one of the largest cities in the U.S., and enhancing the human-nature interactions needed to bolster a global conservation ethos in an urban setting. The existing native vegetation along the Lower Salt River in this area includes Fremont cottonwood (*Populus fremontii*), Goodding willow (*Salix gooddingii*) and mesquite (*Prosopis* spp.) which provide shade and habitat resources.

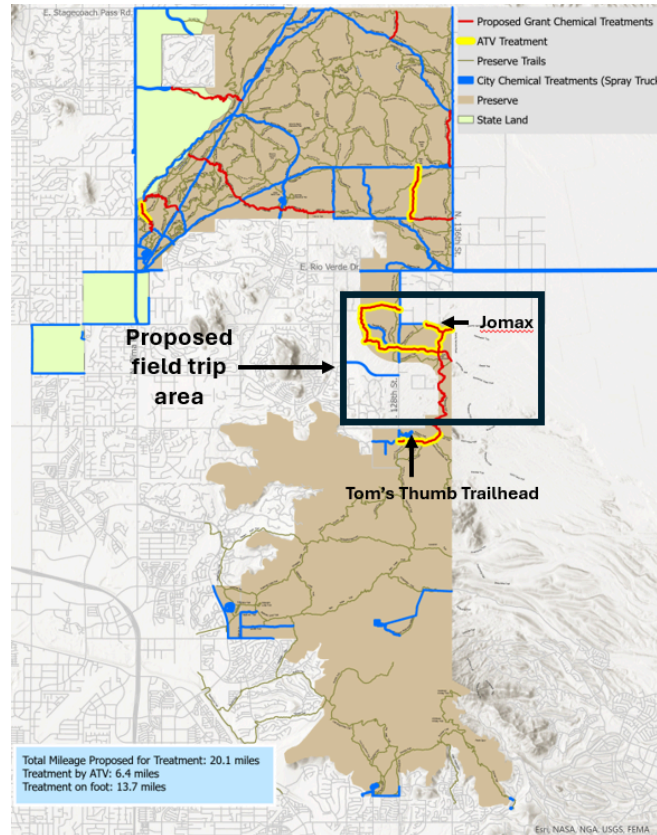


McDowell Regional Park: Guided by Madison Barasha (City of Scottsdale) and Jessica Szopinski (DFFM)

Project Objective: Fine fuel breaks. Treatment primarily focusing on red brome and stinknet.

The McDowell Sonoran Preserve (MSP) is 30,580 acres of permanently protected Sonoran Desert habitat.

The MSP is owned and managed by the City of Scottsdale (COS), with invasive plant removal support from its non-profit partner, the McDowell Sonoran Conservancy (MSC). The MSP and surrounding areas have recently experienced multiple human-caused fires fueled primarily by red brome, which has naturalized across the Sonoran Desert. In 2019, COS began applying pre-emergent herbicides via spray truck to strategic alignments in and around the MSP to interrupt the continuity of fine fuels to provide firefighters an advantage with suppression efforts. Targeted areas include adjacent road shoulders, trailhead parking lot perimeters, and drivable routes within the MSP such as the high-voltage transmission lines. This grant will expand these efforts by applying pre-emergent herbicide along trails strategically selected to enhance the overall effectiveness of the City's wildfire management program.



Topics will focus on the purpose and features of the different approaches, treatment methodologies, workforce engagement, treatment mapping, and all our lessons learned. Shuttles will be provided due to limited parking at McDowell Regional Park site, carpooling is strongly encouraged. Easy road and rocky trail hiking may be required.
